Toxicological Data on Ingredients: Oxalic acid anhydrous: ORAL (LD50): Acute: 7500 mg/kg [Rat].

Section 3: Hazards Identification

Potential Acute Health Effects: Very hazardous in case of skin contact (irritant), of eye contact (irritant), of ingestion, of inhalation. Hazardous in case of skin contact (permeator), of eye contact (corrosive). Slightly hazardous in case of skin contact (corrosive). The amount of tissue damage depends on length of contact. Eye contact can result in corneal damage or blindness. Skin contact can produce inflammation and blistering. Inhalation of dust will produce irritation to gastro-intestinal or respiratory tract, characterized by burning, sneezing and coughing. Severe over-exposure can produce lung damage, choking, unconsciousness or death. Inflammation of the eye is characterized by redness, watering, and itching. Skin inflammation is characterized by itching, scaling, reddening, or, occasionally, blistering.

Potential Chronic Health Effects: CARCINOGENIC EFFECTS: Not available. MUTAGENIC EFFECTS: Not available. TERATOGENIC EFFECTS: Not available. DEVELOPMENTAL TOXICITY: Not available. The substance may be toxic to kidneys, the nervous system, mucous membranes, heart, brain, skin, eyes. Repeated or prolonged exposure to the substance can produce target organs damage. Repeated exposure of the eyes to a low level of dust can produce eye irritation. Repeated skin exposure can produce local skin destruction, or dermatitis. Repeated inhalation of dust can produce varying degree of respiratory irritation or lung damage.

Section 4: First Aid Measures

Eye Contact: Check for and remove any contact lenses. In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Cold water may be used. Get medical attention immediately.

Corrosive solid. Stop leak if without risk. Do not get water inside container. Do not touch spilled material. Use water spray to reduce vapors. Prevent entry into sewers, basements or confined areas; dike if needed.

Eliminate all ignition sources. Call for assistance on disposal. Neutralize the residue with a dilute solution of sodium carbonate. Be careful that the product is not present at a concentration level above TLV. Check TLV on the MSDS and with local authorities.

Precautions:

Keep container dry. Keep away from heat. Keep away from sources of ignition. Empty containers pose a fire risk, evaporate the residue under a fume hood. Ground all equipment containing material. Do not ingest. Do not breathe dust. Never add water to this product. In case of insufficient ventilation, wear suitable respiratory equipment. It may affect the cardiovascular system, and urinary system. Symptoms may include vomiting (often bloody or with coffee-ground appearance), diarrhea, bloody stool, hypermotility, abdominal pain, intense burning pain in the throat, esophagus, stomach, ulceration/burning of the mouth, esophagus, and stomach, severe purging, weak pulse, hypotension, cardiac irregularities, cardiovascular collapse. Other symptoms may include convulsions, headache, twitching, tetany, stupor, coma, tingling of fingers and toes, muscular irritability. Renal damage, as evidenced by oliguria, albuminuria, hematuria, may occur because Oxalic acid can bind calcium to form calcium oxalate which is insoluble at physiological pH. The calcium oxalate formed might precipitate in the kidney tubules. Hypocalcemia may also occur, which is what may affect the function of the heart and nerves and cause the above cardiovascular and nervous system effects. Chronic Potential Health Effects: Skin: Prolonged or repeated exposure may cause localized pain and cyanosis of the fingers, and even
